CONDITIONS OF SALE

1. The State Department for Devolution reserves the right to accept or reject and annul the process at any time prior, without thereby incurring any liability to bidders. In case of annulment, all bidders submitted, and specifically, the deposit, shall be promptly returned to the bidders.
2. Interested bidders are required to pay a refundable deposit of 10% of the reserve price for each lot/item they are interested in. This will be the basis of obtaining the bidding number before the auction date.

6. Upon paying the Interested bidders will be required to present their Bank deposit Slips to the State Department for Devolution's Accounts Office located on 1st Floor, Teleposta Towers, during normal office working hours (8.00 am to 5.00pm) and will thereafter be issued with a **MR receipt**.
7. The issued MR receipt shall be used to obtain the Bidding Number from procurement office at Teleposta Towers, 6th floor.
8. No Bidding whatsoever shall be allowed for a bidder without the Bidding Number.
9. The deposit will be treated as part payment for the successful bidders.
10. The Items/Asset are sold on 'as is where is basis' and are subject to a reasonable reserve price.
11. The successful bidder MUST pay a deposit of 40% of the purchase price by the fall of the hammer.

12. The successful bidders in the public auction shall be given a period of at least seven days from the date of the auction to pay for the items. The purchased Item/ Asset must be collected within seven (7) days after making payment, failure to which the purchaser shall be liable to pay storage charges of Ksh. 1,000 (Kenya Shillings One Thousand) per day.

13. Where the successful bidder fails to meet the requirements in paragraph 12 above, the bidder shall forfeit the bid deposit.

14. The successful bidders shall pay all costs, applicable duties, and taxes assorted with the transfer of the purchased Item/ Asset i.e., motor vehicle.

15. The unsuccessful bidders will be refunded their bid deposits on presentation of the original receipt within a reasonable time after the auction.
